TERMS OF AGREEMENT

This agreement shall apply to future credit (if any) and any existing indebtedness owed by undersigned to **BOXER-NORTHWEST CO. (BNC)**. BNC is authorized to inquire of our bank and trade references, and our personal credit, to evaluate and update our credit worthiness. We agree to abide by the credit terms of BNC as established and amended from time to time. If we do not comply with those terms we agree to pay interest at 18% per annum, plus all collection and attorney fees actually incurred. BNC authorizes that any dispute with undersigned, related to this application or the credit extended thereafter, should first attempt to be resolved through binding arbitration by and under either (a) the Code of Procedure of the National Arbitration Forum or (b) American Arbitration Association. This agreement shall be subject to and interpreted under the Federal Arbitration Act. If a lawsuit is commenced we agree it will take place in Multnomah County, Oregon for all customers doing business in Oregon and all other states and principalities of the US, with the exception of Washington State. Any lawsuit commenced for customers doing business in the state of Washington will take place in King County, Washington. If we sell, transfer or change the ownership or legal structure of our business, we agree to provide written notice thereof delivered to the credit department of BNC, which notice must actually be received. Until we provide such notice, we agree to pay for all purchases made on the account(s) established in our name. A fax copy of this document may, at the option of BNC, be accepted as an original, and thereafter serve as an original.
